# **Guest Participation in RMRA Day Trip Activities**

#### **Process**

- 1. A non-member of Rocky Mountain Ramblers Association (RMRA) who wishes to participate in occasional RMRA day trip activity may do so if sponsored by an RMRA member in good standing for a maximum of 3 times per calendar year.
- 2. Prospective guests must read the RMRA Guest Application and Waiver form and their sponsor must notify the trip coordinator of their wish to attend the trip in advance. (The form may be accessed and completed by the guest's sponsor on-line from the RMRA Website Calendar entry for the trip; by entering the information on-line, an email notification will automatically go to the trip coordinator, prospective guest and their sponsor).
- 3. If the trip coordinator agrees to accept the guest on their trip, they will send an email to that effect to the guest and their sponsor.
- 4. The guest or sponsor must print the completed Guest Application and Waiver form and bring it to the meeting place for the trip, where they will sign it and have it witnessed by the trip coordinator.

Complete this form. Your application will not be accepted:

- if the form is not fully completed;
- if your information is not legible;
- if there are any alterations or deletions in the form; or
- if you do not initial, sign, and date the form.

Your witness should not be a family member, and should observe you sign and initial the form.

#### **Contractual Relationship**

By completing this Guest Application & Waiver form you are agreeing to the terms and conditions set out in this form. By allowing you to sign the Trip Sheet as a participant on an RMRA trip, the RMRA is accepting your application to participate as a guest. Your application is the "offer" and the permission to participate in an RMRA trip constitutes the RMRA's "acceptance" of your offer and, as a result, there is a contractual relationship between you and the RMRA.

## Release of Liability, Waiver of All Possible Claims and Assumption of Risk

The RMRA is not covered by any general liability insurance. The RMRA protects itself and all of the members of the Association from lawsuits by having all members sign a "Release of Liability, Waiver of All Possible Claims and Assumption of Risk" form. By signing this form, you are agreeing not to sue either the RMRA or any of its members, agents or contractors, for any loss or damage you may suffer, whether personal injury, death or property damage, as a result of participating in any activity organized by the RMRA or its members, even if they were negligent and their negligence resulted in injury to yourself or your property or in your death.

By executing the application you are assuming both physical and legal risks.

You are advised to seek independent legal advice to completely understand the implications of this part of the Guest Application form.

## Participant's Responsibilities

#### **Adequate Ability**

I will participate only in Activities where my skill level, physical endurance, current physical condition and mental attitude will allow me to adequately complete the Activity without becoming a burden to the Coordinator or to the rest of the group.

### **Decisions of the Group**

I agree to abide by the decisions of the Group such as those regarding the route taken; trip objectives; turnaround time; pace; and duration and frequency of rest stops.

I agree that I will participate in Group decisions to minimize exposure to known risks, but if such decisions impose physical risks on me greater than my tolerance to risk allows, I agree to immediately inform the Coordinator of my discomfort or my inability or unwillingness to continue. I acknowledge that the Coordinator may cast the tie-breaking vote in group decisions and may propose, if another willing Coordinator or sufficiently experienced and willing member is available, to split the group into sub-groups to accommodate different skill and ability levels.

## Staying with the Group

I will not separate myself from the group and will ensure I remain in sight of other group members. I understand that this may involve going faster or slower than my regular pace and/or waiting for others. At the end of the trip I will wait at the trailhead until everyone is accounted for.

#### Insurance

I will carry my Health Care Card with me while on RMRA activities. I will only volunteer to drive if my vehicle is roadworthy for the day's driving conditions and I have adequate insurance as required by law in the jurisdiction(s) of the drive.

## **Extraordinary Expenses**

I am fully responsible for all costs and expenses which may be incurred in providing any special services to me, outside of regular services agreed to or provided by the RMRA in connection with the Activities, and without limiting the generality of the foregoing, I agree to be responsible for and to pay for all and any costs of rescues, special travel, medical attention or other special outlay for me personally, and to reimburse the RMRA or any member of the RMRA for all costs of these services as may be incurred by them for my benefit or at my request.

I am the full age of 18 years. I am aware of the nature and effect of this Release of Liability, Waiver of All Possible Claims and Assumption of Risk. I am aware of my right to sue the RMRA in the event I sustain loss or damage caused by injury to my person or property, and the right of my personal representatives to sue the RMRA for loss or damage arising from my death, if the physical injury to my person or property or my death was caused by or contributed to by the negligence of the RMRA, and I hereby give up this right on behalf of myself personally and on behalf of my heirs, executors, administrators and assigns in order to join the RMRA and participate in Activities organized or sponsored by the RMRA.

I acknowledge that I have been given the opportunity and have been encouraged to seek independent legal advice prior to signing this agreement.

I am executing this release and waiver of liability agreement freely and voluntarily without any compulsion on the part of the RMRA. I acknowledge having read this entire agreement prior to signing it.
